## EXECUTIVE SUMMARY

---

Capstone Infrastructure Corporation (Capstone or the Proponent), in partnership with Sawridge First Nation (Sawridge), is planning to build and operate the Buffalo Atlee 1, 2 and 3 wind power projects (each a Project and together the Projects) in the Special Areas No. 2, approximately 10 km southeast of Jenner, Alberta.

The three Buffalo Atlee projects won contracts with the Alberta Government under the Renewable Electricity Program (REP) Round 2 procurement administered by the Alberta Electricity System Operator (AESO) for a combined capacity of 48.3 MW. The projects are expected to go into construction in the summer of 2020 and be operational by the end of 2020.

To engage with key stakeholders and interest groups, Capstone planned, advertised and staffed an open house on Wednesday, June 19th, 2019 from 4 to 8 PM at Jenner School in Jenner, Alberta. The public open house was a forum for sharing detailed information about the projects and for providing an opportunity for all stakeholders to receive accurate and timely project information. All occupants, residents and landowners within 2,000 metres of the proposed Projects were notified of the open house via direct mail invitation as well as through advertisements placed in local newspapers (the Prairie Post and Brooks Bulletin) and through posted notices at the Jenner General Store and Jenner Post Office in late May and early June leading up to the event.

The open house was attended by eight (8) individuals, five of which submitted feedback forms. During the open house, fourteen (14) panels were displayed around the room that contained proponent information, project details, an overview of wind power in Alberta, wind farm benefits, project siting considerations (including maps), information about wind turbines and noise, Capstone's consultation process, ongoing environmental studies, regulatory approvals required prior to construction, current Project timelines, and end of Project life information. A Frequently Asked Questions (FAQ) document, and supporting studies and reports on common wind farm issues were provided in hard copy for people to review. A typical wind project design and construction video was also presented to the public on a continuous loop.

Ten (10) representatives attended the meeting on behalf of Capstone. Attendees included subject matter experts on the project design, wildlife, noise, permitting and consultation. The representatives addressed specific issues and concerns, and answered general questions about the projects. Feedback forms were provided to all attendees and any other feedback or questions raised verbally were encouraged and logged.

Feedback received during the open house will be reviewed and incorporated into project planning and design where relevant and practical. Capstone will respond directly to stakeholder concerns and provide timely responses on a case by case basis. Another Open House will be held for the project in the summer of 2019. Capstone also maintains a project website ([www.buffaloatlee.com](http://www.buffaloatlee.com)) for all publicly available information about the project. All information presented at the open house is available on the website.

The projects are subject to approval by the Alberta Utilities Commission (AUC) pursuant to Rule 007: Applications for Power Plants, Substations, Transmission Lines, and Industrial System Designations ("Rule 007"). The Proponent has retained the services of LandSolutions LP to support stakeholder consultation work and to prepare this Open House Summary Report. The information contained in this document will be included in the Participant Involvement Program ("PIP") Summary and provided to the AUC during the regulatory application process.

## OPEN HOUSE PLANNING

In the spring of 2019, Capstone developed a Stakeholder Engagement Plan (“SEP”) which outlines its strategy to effectively engage the public near to its Projects as well as other relevant stakeholders. As part of Capstone’s SEP, a public open house was held on Wednesday, June 19<sup>th</sup>, 2019 from 4:00 PM – 8:00 PM at Jenner School in Jenner, Alberta to inform the public about the proposed projects. Photos of the event location and set up are shown in **Appendix A**.

Occupants, residents and landowners within 2,000 metres of the proposed Project boundaries were notified of the open house via invitation sent by regular mail on June 4, 2019. A total of 52 individuals were mailed open house invitations. A complete list of stakeholders and interest groups that were invited to the open house is provided in Table 1 – Key Stakeholders & Interest Groups.

## OPEN HOUSE NOTICES

---

Open house notices (advertisements) were published in the Prairie Post and the Brooks Bulletin newspapers in May and June 2019. The Prairie Post is published weekly on Thursdays with a distribution of approximately 17,000 readers in southeast Alberta. The Brooks Bulletin is published weekly on Tuesdays with a distribution of approximately 3,000 readers in the communities of Brooks and the County of Newell. The open house notice was published in the Brooks Bulletin on May 28 and June 4, 2019 and in the Prairie Post on May 31 and June 7, 2019.

Through consultation with local residents of the area, and representatives of the Special Areas, Capstone identified two local bulletin boards that could also advertise the open house notice. Notices were displayed on the local bulletin boards at the Jenner General Store and the Jenner Post Office for over 2 weeks prior to the open house in an effort to reach and inform local residents of the event.

## OPEN HOUSE INFORMATION PROVIDED

---

The open house provided detailed information about the Projects and allowed all stakeholders to receive the same information at the same time and have direct face to face interaction with project team members and subject matter experts. There were ten (10) knowledgeable Proponent representatives at the open house to address specific issues or concerns raised about the projects. Project team members and subject matter experts are summarized below in Table 2 – Proponent Representatives.

Information at the open house was provided in the form of fourteen (14) large format presentation panels, hard copy materials and take-home handouts, visual presentations, resource stations with enlarged maps, studies, a video showing a typical wind project design and construction, and additional supporting documentation. The studies and project information presented at the open house are available for viewing and download on the Project website at [www.buffalootlee.com](http://www.buffalootlee.com). The panels were grouped by theme, with subject matter experts present to explain the materials, receive feedback and answer questions. Please see **Appendix C** for copies of the panels presented during the open house.

In addition to the information presented on the panels, additional information was available in the form of a Frequently Asked Questions (FAQ) document addressing common questions asked about the projects. Furthermore, hard copies of the source reports and studies supporting the conclusions of the FAQ were also on display at the open house and made available for public review and comment. The FAQ document covers the following topics and is also available on the website for other members of the public to review:

- Noise
- Wildlife
- Health
- Visual Impact
- Turbine lighting
- Property Value
- Decommissioning
- Ground Vibrations

Finally, a video demonstrating standard construction practices for wind farms was shown in one corner of the open house hall. The video was on a recurring loop and showed different aspects of site preparation, civil and electrical construction work and the final assembly and installation of the turbines themselves.

## FEEDBACK RECEIVED

---

Capstone representatives encouraged individuals to explore all areas of the open house and ask questions. Feedback forms were available for stakeholders to provide written feedback and present any additional questions, concerns or issues. Proponent representatives were also on hand to write down and document verbal feedback during the open house. All of the feedback was tabulated and compiled and will be used for project design changes, or for direct follow up with individual stakeholders. Capstone commits to timely responses and follow up activities with all consultation feedback. Anyone who filled out a feedback form and requested additional consultation will receive a follow up and all communication will be captured in the consultation log.

The open house for the projects was attended by eight (8) individuals and Capstone received written feedback forms from five (5) individuals. A template of the feedback form is provided in Appendix D, and all feedback forms received are provided in Appendix E (redacted of all personal information). Feedback received is provided below in Table 3 –Summary of Feedback and Table 4 – Summary of Comments.

**NEXT STEPS**

Information and feedback received from the open house will be used to review the layout of the Projects and finalize turbine locations. A second open house is tentatively planned for August 2019. More details will be sent to all stakeholders prior to the date.

Information packages presenting the layout updates and the final layout design for the Projects will also be prepared and sent out prior to filing the Projects with the Alberta Utilities Commission (AUC).

The general consultation plan will continue to follow the Stakeholder Engagement Plan (SEP) and further updates on the Projects will be provided via mail and will be updated regularly to the Project website.

## CONCLUSION

---

As an industry-leading project developer, Capstone is committed to applying best practice for public consultation and engagement throughout the lifecycle of the Buffalo Atlee projects. Capstone's approach to outreach is grounded in its belief that those affected by its business have a right to be informed about activities, participate in decision making through transparent processes and be involved in addressing issues and opportunities that affect them.

The SEP for the Projects provides a framework that defines how Capstone will consult and engage with the community. Under the framework of the SEP, Capstone held the first public open house for the Projects on June 19, 2019, from 4 to 8 pm. The event was advertised in the Brooks Bulletin and the Prairie Post, as well as via mail to all local residents and stakeholders close to the Projects. Notices were also posted at the Jenner General Store and at the Jenner Post Office. Ten representatives were present for Capstone, and materials included 14 information panels, an FAQ document, hard copy studies and reports supporting the FAQ, and a video presentation for project construction. Eight attendees came to the meeting, and five feedback forms were completed and submitted. Follow ups are planned and where possible the feedback from the event will help guide final site design for the Projects.

Capstone is proud to be a contributing member of the community and will continue to build trust and demonstrate integrity as a result of its frequent, open and honest communication. Capstone will demonstrate a diligent approach to addressing stakeholders' concerns and finding solutions and providing mitigation strategies that incorporate community feedback into project planning and project design where applicable.

As new, long-term partners in the hamlet of Jenner in the rural municipality of Special Areas No.2 in Alberta, Capstone and Sawridge First Nation aim to further enrich the community and add to the social benefits associated with wind power. In future consultation, Capstone will announce ways in which it plans to contribute to the Jenner community based on the feedback received at the open house event.

## Wind Power in Alberta

- Canada's first commercial wind farm was built on Cowley Ridge, near Pincher Creek, in 1993.
- Over 900 turbines are currently installed across the province as part of 37 total projects.
- Alberta has an installed wind energy capacity of 1,483 MW. Wind farms in Alberta produce enough electricity each year to power about 380,000 average sized homes.
- Coal-fired generation in Alberta will be phased out by 2030, and renewable energy generation is expected to increase to more than 30% by 2030.

## Where does Alberta's power come from?



## Renewable Electricity Program (REP)

- The REP was developed to support the Government of Alberta's goal of 30 per cent renewable electricity by 2030.
- The REP project contracts have a *contract for difference* structure. These projects receive a top up payment when revenue is below a set price. When the Power Pool price rises above the set price, excess revenue is paid back to the government.
- The power prices for the 12 winning projects from REP 1, 2 and 3 in 2018 and 2019 range from 3.1 to 4.3 cents/kilowatt-hour. These are record prices across Canada for wind power and represent the lowest cost new generation in Alberta.





## Wind Farm Benefits

- Through the Buffalo Atlee projects, Capstone and Sawridge First Nation aim to further enrich and strengthen the community and add to the social benefits and sustainability associated with wind power.

### Local services and employment

- Local services and commercial businesses will be utilized to the extent available
- Local qualified contractors and labourers will be engaged for construction
- Construction materials will be sourced locally whenever possible



### Operations employment

- Long-term employment will be created during operations for site managers, technicians, as well as secondary services for site maintenance



### Tax revenues

- Municipal tax revenue will be increased, which will offset gaps in revenue and stabilize taxes for all Special Areas residents

### Landowner royalties

- Host landowners will receive annual revenue which is often invested back into their businesses and the broader community







## Wind Turbines and Noise

- All wind energy projects must comply with Alberta Utilities Commission (AUC) Rule 012: Noise Control.
- A Noise Impact Assessment (NIA) will be completed for all residences and dwellings within 1.5 kilometers of the project (“noise receptors”).
- All receptors must be at or below the noise limit thresholds (50 dBA daytime, 40 dBA nighttime limits). Our layout is designed to conservatively meet 40 dBA day or night.
- The noise model considers sound from the project and nearby operational and proposed energy and industrial facilities (other wind farms, solar, oil & gas, etc.)
- Noise compliance, among other environmental and social considerations, will determine the final turbine layout.

## Stakeholder Consultation Process


- Wind projects must follow Alberta Environment and Parks (AEP) siting guidelines to minimize impacts on local wildlife including birds and bats

- Capstone is working closely with AEP to assess potential risks and implement appropriate mitigation measures
- A wildlife monitoring program will be undertaken to assess whether any additional mitigation is needed

## Approval Process for Wind Projects in Alberta

- The Alberta Utilities Commission (AUC) is the governing approval body for power plants, including wind farms, in Alberta.
- Prior to commencing construction, additional permits will be required from other non-government agencies (e.g., for new or upgraded approaches, building permits, aviation clearance, etc).

## End of Project Life

- The wind turbines planned for the Buffalo Atlee 1/2/3 wind projects are expected to be operational for more than 30 years.
- Given the renewable fuel source (the excellent wind resource), there is always some value at the site and so the project operations may be extended, depending on market conditions at that time, which is very different from oil and gas wells.
- At the end of the useful life of the wind turbines, Capstone will assess whether to repower or decommission the site
- If decommissioning is necessary, significant residual value from equipment is anticipated at end of life.

## Repowering

- Turbines and/or other infrastructure may be upgraded and reused.
- Cowley Ridge wind farm, the first commercial wind farm installed in Canada, was recently taken down and a new project is being proposed on the site after more than 25 years of operation.

## Decommissioning

- Turbines and infrastructure are removed and the land is restored to its original or equivalent land use.
- Decommissioning and reclamation will be completed based on the *Conservation and Reclamation Directive for Renewable Energy Operations* (AEP) and any updates at that time.
- Some underground infrastructure at depth of greater than 1 metre may be left in place if it has no impact on the surface land use and is in compliance with all laws and regulations in place at that time.
- Waste and debris generated during decommissioning activities will be collected and disposed at an approved facility.






